DISPUTES; NO ELECTRONIC PROTESTS, NOTICES OF CLAIM, OR CLAIMS: THIS CONTRACT SHALL BE SUBJECT TO THE PROVISIONS OF TITLE 15, SUBTITLE 2 OF THE STATE FINANCE AND PROCUREMENT ARTICLE OF THE ANNOTATED CODE OF MARYLAND AND COMAR.21.10 (ADMINISTRATIVE AND CIVIL REMEDIES).
