PRICE ESCALATION/DE-ESCALATION: UPON WRITTEN REQUEST TO THE PROCUREMENT OFFICER, PRICE ESCALATIONS WILL BE CONSIDERED AT THE TIME OF EACH RENEWAL AND SHALL BE BASED ON THE PERCENTAGE CHANGE IN THE U.S. DEPARTMENT OF LABOR, BUREAU OF LABOR STATISTICS (BLS) PRODUCER PRICE INDEX (PPI) FOR "DRY AND SEIM MOIST DOG FOOD, SHIPPED IN PACKAGES OF 25 LBS OR MORE", NUMBER WPU 0294020213, NOT SEASONALLY ADJUSTED, FOUND AT WWW.BLS.GOV/PPI/.
