

2022 October Capital Grants – Administered by the Maryland Department of General Services

Baltimore Unity Hall - Is utilizing their **\$200,000** grant to the project consists of Basic and Specialty Services from Schematic Design through Construction Administration for the core and shell renovation of the existing building. (Baltimore City)

The Howard County Conservancy – Grant totaling **\$130,000** the project will increase accessibility and address erosion problems along the trail closest to the Conservancy's Nature Center. The project will mitigate stormwater runoff issues.

Building African American Minds, Inc- Academic Center - Is utilizing their **\$250,000** grant to the project consists of Build a 3-story building to house all programming and staff; current afterschool and summer programs; eventual educational & career focused programs for the youth as well as parents, young adults seeking employment services and the public. (Talbot County)

Building African American Minds, Inc- Academic Center - Grant totaling **\$800,000** the project will be used to build a 3-story building to house all of its programming and staff; current afterschool and summer programs; eventual educational & career focused programs for the youth as well as parents, young adults seeking employment services and the public. Southern Crossing – Grant totaling **\$550,000** the project will allow the organization to provide 47 units for households in transition. St. John's Methodist Church Restoration - Is utilizing their **\$120,000** grant to improve and restore the cemetery containing the remains of about 40 members, to include markers for unmarked graves, walking paths and benches for visitors, and a memorial identifying the names of the individuals buried on the site. involves excavation, grading, and construction of block foundation, framing of walls for church, electrical and plumbing. (Calvert County)

Rash Field – Grant totaling **\$500,000** the project will allow Phase 2 of Rash Field Park, including soccer fields, jogging paths, native gardens, outdoor exercise equipment, and relocation of the Pride Memorial. (Baltimore City)

Harlem Park Community Center - Is utilizing their **\$200,000** grant will be to rehabilitate the community center in Harlem Park. The newly renovated property will be used as a community as a community and co-working space and will include a cafe and fresh produce retail space. (Baltimore City)

Severna Park American Legion Post 175 – Grant totaling **\$55,000** the project will allow improvements to kitchen, new stove, coolers. Improvements to the parking lot and outside

restrooms. All labor for kitchen improvements will be donated labor will be used by legion members. (Anne Arundel County)

Crownsville Hospital Memorial Park - Is utilizing their **\$25,500,000** grant to be used for planning/design and construction for remediation of the property and improvements to make the property safe and accessible for use. (Anne Arundel County)

Crownsville Hospital Patient Cemetery Park – Grant totaling **\$100,000** the project will be used for planning/design and construction of a memorial for patients buried in the cemetery in order to provide dignity in death, and respect and genealogical record for families and communities. (Anne Arundel County)

Pleasant View Historic Site Restoration - Is utilizing their **\$100,000** grant to be used for Phase 1 renovations to the two-room schoolhouse functioned as a meeting space for the local community. (Montgomery County)

Kennedy Krieger Institute - Center for the Neuroscience of Social Injustice – Grant totaling **\$2,500,000** the project will address the immediate needs of the Maryland community by developing a better understanding of the impact of social influences and injustice on child development. This will be achieved by renovating and modernizing the space, which will allow successful recruitment and accommodation for new scientists, including researchers for the Center, and allow for flexibility in research methodology and focus. (Baltimore City)

Calvert Elks Lodge - Is utilizing their **\$60,000** grant to be used for the capital improvements to the Elks Lodge include the total replacement of the HVAC system. And a new packaged commercial HVAC system shall be a scaled set of interconnected systems. The design and installation of these systems will maximize airflow, air balance, and help heating and cooling be even, predictable, controlled, and cost-efficient in the building. (Calvert County)

Cecil County Farm Museum - Is utilizing their **\$95,000** grant to be used for compliant restroom building which includes a mechanical room and space for a kitchen. This new construction will involve the installation of a complete waste-water management system; potable water, HVAC system; and a 100-amp electric feed and service panel.

College Park Roods Neighborhood Park – Grant totaling **\$200,000** the project will be used for site improvements to the park to include the addition of fitness stations. (Prince George's County)

Blohm Park Trails Project - Is utilizing their **\$250,000** grant to create trail improvements at Blohm Park, including adding a boardwalk and raised overlook for the city. (Montgomery County)

Epiphany House and Micah House – Grant totaling **\$250,000** the project will be used to renovate these properties to preserve affordable housing for those who have experienced homelessness, older adults, and those with disabilities. (Baltimore City)

Akhmedova Ballet Academy Third Studio Expansion - Is utilizing their **\$75,000** grant to create the new studio that will allow for expansion of the professional training program (PTP) as well as starting a professional ballet company in Montgomery County.

Children's Theatre of Annapolis- Annex Renovation and Expansion – Grant totaling **\$300,000** the project will be used for CTA's goal is to make the annex into an environmentally controlled 3 room building that would allow building the education program and the extension of outreach to underserved families. (Anne Arundel County)

Morning Star Family Life Center - Is utilizing their **\$1,400,000** grant to acquire funds for completing renovation of the MSBC Five Star Community Family Life Center (The Star Community FLC). This will allow us to expand our services to meet the increasing needs of West Baltimore County and surrounding communities

Patuxent River Naval Air Museum and Visitor Center - Grant totaling **\$100,000** the project will be used for a stand-alone monument style roadside electronic messaging center. (St Mary's County)

Gallagher Services Community Center - Associated Catholic Charities, Inc. will be utilizing the **\$1,000,000** grant to renovate and replace an outdated day-program to that will support individuals with intellectual and developmental disabilities. This new facility is being built as a central hub for this population of individuals. (Baltimore County)

Cromwell Valley Park - Grant totaling **\$200,000** for improvements to the park's grounds that will include structural renovations to facilities on the park grounds. This will include construction of accessible walkways to improve access to park facilities and enhancements to the entrance and approach roadways. (Baltimore County)

New Brooklyn Heights Community Center - Grant totaling **\$400,000** for revitalization and repurpose of the Brooklyn Heights Park to include walking paths, lighted multipurpose field, adaptive baseball/softball fields, basketball court, community garden, meditation area, dog park, parking lot improvements, and stormwater management. (Anne Arundel County)

Odenton Masonic Center - Grant totaling **\$75,000** for the revitalization improvements to the Center. (Anne Arundel County)

University of Maryland – St. Joseph Medical Center - Grant totaling **\$970,000** to relocate and renovate portions of the medical center to accommodate an inpatient and outpatient Pediatric Unit. The renovations will include five private inpatient pediatric rooms and five renovated outpatient rooms. (Baltimore County)

Wild Kid Acres – Is utilizing their **\$250,000** grant for design, construct, and finish two structures at the Wild Acres Community Barn and the riding arena. (Anne Arundel County)

Guide Right Facility - Grant totaling **\$550,000** for the repairs and improvements to their basement, bathrooms, front area, porch, offices, and other areas. (Prince George's County)

Old Town Bowie – Historical Properties – Is utilizing their **\$500,000** grant for the acquisition, planning, design, construction, repair, reconstruction, site improvement, and capital equipping of historic properties located in Old Town Bowie. (Prince George's County)

The Community Ecology Institute - Grant totaling **\$450,000** to maximize their ability to uniquely serve the community through the purchase, repairs and improvements to the Green Farmacy Garden (GFG), which is a plant and seed sanctuary. And the need for the building to be renovated as a fully functional, community engagement center - bathrooms, meeting, class and office spaces, etc. (Howard County)

Pearlstone Center – Is utilizing their **\$2,500,000** grant for the acquisition, planning, design, construction, repair, reconstruction, site improvement, and capital equipping of historic properties located in Old Town Bowie. (Baltimore County)

The Digital Bay Center - Grant totaling **\$350,000** for the construction, technological updates, and renovations to their dining room, bathrooms, roof, offices, and other areas. (Baltimore County)

NorthBay Environmental Education Center – Is utilizing their **\$2,300,000** grant for the construction, repair, site improvement, and safety equipping of the NorthBay Center's waterfront and facility. (Cecil County)

Humanim - Grant totaling **\$150,000** for this project will expand and improve the facilities to meet the needs of adults who have been diagnosed with developmental and/ or psychiatric disabilities. (Howard County)

the community to connect to the center's wireless internet. The center will also support a vibrant community farmers' market. (Carroll County)

South Shore Recovery Club (SSRC) – Is utilizing their **\$28,970** grant to renovate by repaving and striping of the front, rear and sides of the existing parking lot. (Anne Arundel County)

Corkran Middle School Concession Stand - Grant totaling **\$1,000,000** for this project will expand and improve the facilities to meet the needs of adults who have been diagnosed with developmental and/ or psychiatric disabilities. (Anne Arundel County)
