SOLE SOURCE SPECIFICATIONS OFFSHORE WIND POWER DEPARTMENT OF GENERAL SERVICES

1.BACKGROUND AND PURPOSE

- A. The State of Maryland ("State") has a goal to achieve 8,500 megawatts of offshore wind power capacity by 2031 (Md. Code Ann., Public Utilities Article Section 7-704.1).
- B. The Department of General Services ("DGS" or "Department"), in compliance with Md. Code Ann., Public Utilities Article Section 7-704.4, is issuing these sole source specifications to enter a power purchase agreement ("PPA") with (contractor) of no less than twenty (20) years in duration to procure offshore wind power including all associated renewable energy credits ("RECs") and other environmental attributes.
- C. The Contractor, both directly and through its subcontractor(s) or Designated Agent(s) must be able to provide all goods and services and meet all of the requirements requested in these specifications and the PPA. As used here and in the PPA, a "Designated Agent" is a third party authorized by the State or the Contractor to perform the day-to-day obligations of the PPA. The Contractor shall remain responsible for the performance of the PPA regardless of the participation of subcontractors or Designated Agents in the work.

2.CONTRACTOR REQUIREMENTS- GENERAL

The Contractor shall:

- A. Hold site control of a lease area from the United States Department of the Interior on the outer continental shelf of the Atlantic Ocean more than ten miles off the coast of the State.
- B. Have the ability to and provide documentation of the ability to connect from the lease area to the PJM Interconnection, LLC ("PJM") grid at a point located on the Delmarva Peninsula. The Delmarva Peninsula contains the peninsula between the Chesapeake and Delaware bays, including most of Delaware and those parts of Maryland and Virginia east of the Chesapeake Bay.
- C. Have a Federal Energy Regulatory Commission ("FERC") power marketing license as well as PJM membership as a Generation Owner. The Contractor shall have entered into all required PJM agreements required for the performance of its obligations in connection with the Facility (an offshore wind-powered generating facility located off the coast of the Delmarva Peninsula). These agreements shall be in full force and effect, or the Contractor shall have

entered into an agreement with a market participant that will perform all the Contractor's PJM-related obligations in connection with the Facility and Attachment T, the PPA.

- D. An overall not to exceed Minority Business Enterprise (MBE) subcontractor participation goal of 15% and a Veteran Small Business Enterprise (VSBE) goal of 3%, representing a percentage of the total PPA dollar value, including all renewal option terms, if any, has been established for this procurement.
 - 1) Notwithstanding any subgoals established for this RFP, the Contractor is encouraged to use a diverse group of subcontractors and suppliers from any/all of the various MBE classifications to meet the remainder of the overall MBE participation goal.
 - 2) By submitting a response to this solicitation, (contractor) acknowledges the overall not to exceed MBE subcontractor participation goal and subgoals and commits to achieving the overall goal and subgoals by utilizing certified minority business enterprises.

3. Contractor Submittals

- A. Provide proof and description of the lease and lease area covered in Par. 2(A) above.
- B. The Contractor shall include with its response to these specifications any applications filed, or agreements held with PJM (and, if needed, waive confidentiality with PJM for verification of the applications or agreements).
- C. Provide documentation and attestation of the licenses and agreements outlined above in 2 (C).
