Minutes:

I. Welcome

- Emily Soontornsaratool welcomed all the attendees to the quarterly Green Purchasing Committee meeting and reviewed the agenda. She informed attendees that this meeting will be recorded.
- II. Announcements
 - DGS
 - The State of Maryland has awarded a Master Contract for electric vehicle charging infrastructure. 13 suppliers have executed Master Agreements, effective June 1, 2024 through May 31, 2027. *See the contract <u>here</u>*.
 - DGS celebrated its 200th EV charging port.
 - Decarbonization Planning and Building Energy Performance Standards
 - The Office of Energy and Sustainability has contracts with 3 decarbonization planning consultants for electrifying State buildings and facilities. This contract is not only available to state agencies, but local entities and non-profits as well. David St. Jean asked if anyone is interested in decarbonization planning to contact him for a form to engage with one of the contractors.
 - MDOT-TSO
 - David Hollens mentioned TSO is close to finalizing their lighting retrofit project using one of the lighting contracts with Grainger. He invited anyone who has questions about the process or lessons learned from the lighting contract to contact him.
 - MDE
 - Tim Kerr announced that MDE will be moving their offices to a different location, inferring that they will be procuring several types of commodities to restock the offices, including furniture and computers.

III. Presentation: *Products, Solutions, & Services Sustainability at Dell Technologies,* Alyson Freeman and Steve Alagna, Dell.

Alyson Freeman, The Sustainability Innovation Lead with Dell, gave a presentation on their environmental sustainability goals with Dell.

- Dell has technologies to help customers meet sustainable IT goals, including reducing the footprint of IT, partnering for a sustainable data center, driving innovative business models, and delivering sustainable recovery & recycling. They offer a range of green IT products that are third party verified by ecolabels EPEAT, TCO and 80 plus.

Steve Alagna, Senior Sustainability Packaging Engineer with Dell, gave a presentation on Dell's sustainable packaging, and the database used to track its progress.

• As part of Dell's ESG report, one of their goals is for packaging to be made from 100% recycled material, renewable material, or reused packaging by 2030. they are able to digitize packaging data through working with Smartsheet. This enables suppliers to enter their data into one platform and automates into one aggregate spreadsheet. Every supplier has their own data report.

- Question from Tim Kerr: Who takes your IT products for recycling/reuse? Answer: Dell works ITAD and has six partners distributing for reuse. They can do reports to track where the IT was distributed for reuse and find third party certifications.
- Question from Sam Linton: Have you been able to get post-consumer recycled content for IT accessories that cannot be third party verified? Answer: Yes, recycled plastic and steel are especially reported in their dashboard, and it is verified by a third party.
- Question: Is the Smartsheet hosted in the cloud? Answer: Yes, Dell has a corporate license and the data is confidential and secure via Smartsheet.
- Question: Was there any pushback in transitioning suppliers to report via Smartsheets? Answer: 100% of suppliers have been sending their reports. There was little pushback because they have been reporting for a couple years.
- IV. GPC Business & Activities Update provided by Vicki Nellis.
 - Approval of Meeting Minutes
 - The GPC meeting minutes for May were motioned to approve by Thomas Hickey with the University System of Maryland. Carla Thompson with the Department of Information Technology seconded the motion, and the meeting minutes were approved.
 - FY2025 Goals
 - The GPC has several goals for the next fiscal year, including increasing green contracts in eMMA by 50%, increasing green specifications by 10%, expanding training opportunities, increasing statewide compliance with green purchasing, and more.

 - Specifications Template.
 - The GPC has reformatted the template for developing specifications.
 - Thomas Hickey motioned to approve the specification. Carla Thompson seconded the motion, and the specification was approved.
