PRODUCT SPECIFICATION: THE MINIMUM ORDER FROM THIS SOLICITATION SHALL BE FIFTY (50) POSTS TOTAL TO ANY ONE LOCATION PER ORDER. ALL POSTS WILL BE #1 DENSE SOUTHERN YELLOW PINE TREATED WITH COPPER ARSENATE (CCA), TYPE A, B, C, WITH 49% RETENTION. UPON DELIVERY ALL POSTS SHALL BE SMOOTH SURFACES ON ALL FOUR SIDES.

EACH PIECE OF LUMBER SHALL BE GRADE MARKED BY AN AGENCY ACCREDITED BY THE AMERICAN LUMBER STANDARD COMMITTEE (ALSC) [HTTP://WWW.ALSC.ORG/](http://www.alsc.org/), AND MANUFACTURED IN ACCORDANCE WITH PRODUCT STANDARD PS 20, PUBLISHED BY THE U.S. DEPARTMENT OF COMMERCE.

QUALITY CLAUSE: ANY POST FOUND TO HAVE EXCESSIVE SPLITTING OR WARPING WILL BE RETURNED AT THE VENDOR'S EXPENSE. PRODUCT ACCEPTABILITY SHALL BE AT THE SOLE DISCRETION OF THE STATE AGENCY PURCHASING THE PRODUCT.
