UNDER THIS CONTRACT.

CONTRACT SCOPE: THE PURPOSE OF THIS CONTRACT IS TO SUPPLY THE MARYLAND TRANSIT ADMINISTRATION (MTA) WITH BULK ANTIFREEZE AT A FIRM FIXED PRICE FOR THE TERM OF THIS CONTRACT.

VENDOR WILL SUPPLY EXTENDED LIFE ANTIFREEZE, PREDILUTED WITH DEIONIZED WATER TO A 50/50 MIX, DELIVERED TO BULK TANKS AT MTA FACILITIES IN THE BALTIMORE AREA.

CONTRACT ACCEPTANCE: THE BLANKET PURCHASE ORDER (BPO) ISSUED AS A RESULT OF THE INVITATION TO BID (ITB), #001IT819759/MDDGS31018234, AND ANY SUBSEQUENT AMENDMENTS, MODIFICATION OR OPTIONS ISSUED RELEVANT TO THE ITB OR BPO, SHALL COMPLY WITH ALL OF THE TERMS, CONDITIONS, AND SPECIFICATIONS ISSUED WITH THE ITB AND ARE INCORPORATED HEREIN AND MADE A PART OF THE BPO.

PRODUCT SPECIFICATIONS: THE ANTI FREEZE SUPPLIED UNDER THIS CONTRACT SHALL MEET THE FOLLOWING STANDARDS:

ANTIFREEZE SHALL BE SUITABLE FOR USE IN DIESEL ENGINES IN INTRA-CITY BUSES FOR A PERIOD OF SIX (6) YEARS.

ANTIFREEZE SHALL NOT REQUIRE PRECHARGE OF SUPPLEMENTAL COOLANT ADDITIVES. IT SHALL NOT REQUIRE SUPPLEMENTAL COOLANT ADDITIVES DURING THE SIX (6) YEAR PERIOD EXCEPT ONE APPLICATION OF A RECHARGE PACKAGE (EXTENDER) AFTER THREE (3) YEARS.

PRODUCT SHALL BE ETHYLENE GLYCOL AND A CARBOXYLATE INHIBITOR.

ANTIFREEZE SHALL BE FREE OF BORON, NITRATES, SILICON, PHOSPHATES AND AMINES.

INHIBITOR SHALL BE FORMULATED TO MAINTAIN AT LEAST 80% POTENCY AFTER THREE (3) YEARS.

PRODUCT MUST PASS CUMMINS ENGINEERING STANDARD 14603 FOR USE IN HEAVY-DUTY DIESEL APPLICATIONS.

CONTRACT TERM: THE TERM OF THIS CONTRACT WILL BE FOR ONE (1) YEAR FROM JUNE 8, 2019 THROUGH JUNE 7, 2020. THIS CONTRACT MAY BE RENEWED AT THE UNILATERAL DISCRETION OF THE MARYLAND TRANSIT ADMINISTRATION (MTA) AND THE DEPARTMENT OF GENERAL SERVICES (DGS) FOR ONE (1) ONE-YEAR TERM, UNDER THE SAME TERMS AND CONDITIONS.

QUANTITIES: MTA PLANS TO REPLACE THE STANDARD ANTIFREEZE NOW IN USE WITH EXTENDED LIFE ANTIFREEZE. APPROXIMATELY SIXTEEN THOUSAND

(16,000) GALLONS WILL BE REQUIRED FOR THE REPLACEMENT. THEREAFTER ANTIFREEZE WILL BE USED TO TOP OFF TANKS. MTA ANTICIPATES A LARGE DEMAND EARLY IN THE CONTRACT, WITH A DECREASED NEED AFTER THE REPLACEMENT. ESTIMATED QUANTITY FOR THE INITIAL TERM IS 24,000 GALLONS. QUANTITIES ARE ESTIMATES AND SHOULD NOT BE CONSIDERED A GUARANTEE. ACTUAL USE WILL BE AS REQUIRED BY MTA.

CERTIFICATION: THE APPARENT LOW BIDDER SHALL PROVIDE LABORATORY CERTIFICATION FROM HIS SUPPLIER/BLENDER THAT THE PROPOSED ANTIFREEZE MEETS THIS SPECIFICATION IN ITS ENTIRETY. THIS CERTIFICATION SHALL BE DELIVERED TO MTA QUALITY ASSURANCE DEPARTMENT FOR REVIEW. NOTICE OF AWARD IS DEPENDENT UPON MTA QUALITY ASSURANCE APPROVAL OF THIS CERTIFICATION.

TESTING: ANTIFREEZE SHALL BE SAMPLED AND TESTED PERIODICALLY FOR SPECIFICATION COMPLIANCE. IFA DELIVERY DOES NOT MEET THIS SPECIFICATION THE CONTRACTOR SHALL BE LIABLE FOR REMOVAL OF THE NONCOMPLIANT PRODUCT FROM MTA VEHICLES AND FACILITIES. CONTRACTOR SHALL ALSO BE LIABLE FOR ALL COSTS OF ANY REPAIR OR REPLACEMENT CAUSED BY DELIVERY OF PRODUCT THAT DOES NOT COMPLY WITH THIS SPECIFICATION. MTA MAY CANCEL THE CONTRACT FOR CAUSE IF SAMPLES DO NOT MEET THE SPECIFICATIONS.

STANDARD PHYSICAL AND CHEMICAL REQUIREMENTS: EXTENDED LIFE ANTIFREEZE SHALL BE COMPATIBLE WITH STANDARD ANTIFREEZE TO THE EXTENT THAT TOPPING OFF STANDARD ANTIFREEZE WITH EXTENDED LIFE ANTIFREEZE DOES NOT DEGRADE ANTIFREEZE QUALITY WITH RESPECT TO STANDARD ANTIFREEZE. SUCH MIX SHALL NOT BE REQUIRED TO HAVE EXTENDED ANTIFREEZE LIFE.

DELIVERY: DELIVERY SHALL BE TO BULK TANKS AT MTA FACILITIES, LISTED BELOW. DELIVERY TRUCK TANKS SHALL BE COMPLETELY FLUSHED OF OTHER PRODUCTS, INCLUDING STANDARD ANTIFREEZE. CONTRACTOR SHALL FAMILIARIZE HIMSELF WITH THE BASES AND TANK LOCATIONS BEFORE BIDDING. SOME OF THE ANTIFREEZE TANKS ARE ABOVE GROUND. AS THIS WILL AFFECT PRODUCT TRANSFER VENDOR SHOULD BECOME FAMILIAR WITH TANKS AND UNDERSTAND THEY ARE ABOVE GROUND.

A CERTIFIED SCALE OR GALLON-METERED TICKET SHALL BE PROVIDED WITH EACH LOAD. BILLING TICKET SHALL INCLUDE THE PCA CODE FOR EACH LOCATION.

DELIVERY SHALL BE MADE WITHIN TWO (2) WORKING DAYS AFTER NOTIFICATION BY MTA. DELIVERY SHALL BE MADE BETWEEN 8:30 A.M. AND 3:30 P.M., MONDAY THROUGH FRIDAY, EXCEPT HOLIDAYS. DRIVER SHALL REPORT TO BASE SUPERINTENDENT OR HIS DESIGNEE UPON ENTERING A BASE. PRODUCT SHALL NOT BE DROPPED UNTIL DIRECTED BY SUPERINTENDENT OR HIS DESIGNEE.
