2022 April Capital Grants – Administered by the Maryland Department of General Services

Baltimore Pumphouse's grant totaling \$75,000 will enhance safety and attract new residents and visitors to several new developments underway north of the rail line. The landmark will also help connect residents to amenities that are south of the rail line. (Baltimore City)

Blue Line Corridor Public Art Projects is utilizing their \$1,000,000 grant to provide benefits in terms of economic development, community engagement, destination wayfinding and improving pedestrian and bike-able experiences. (Prince George's County)

Clay Hill Public Charter School grant totaling \$300,000 will assist with a demand from parents for a whole-child education and an 1,800-seat deficit, causing overcrowding and the highest school building utilization rate of Baltimore's six planning areas. Knowing these factors, PPPCS, Inc. decided to build on our history of excellence and open CHPCS to serve 540 more students with our signature whole-child education. (Baltimore City)
